



4.	Environment Report	Steve Rae reported on external contacts, noise, dust, water, waste and revegetation since the last meeting. Additional discussion was held: <i>External Contacts</i> There were zero external contacts. <i>Noise</i> There were zero noise level exceedances reported for our community monitoring stations. <i>Dust</i> Dust management remains a constant focus. Dust controls are in place as part of operating procedures. All licence limits have been complied with for dust deposition and total suspended particulates to date at our community monitoring stations.         Dust deposition bottles were removed prior to TC Iris to prevent sample being void by rainfall or bottles breaking from wind. They have since been reinstated and data should be validated for use in next month's report. <i>Water</i> DBCT received approximately 180mm of rainfall associated with TC Iris and did not discharge during this event. Water storage volumes are sufficient to ensure
